



CONDITIONS OF ENTRY – PLEASE READ PRIOR TO ENTERING


- 1. ASSOCIATION LIABILITY:** RWWA/SPPHAWA or any of its agents shall not be liable for any financial loss or damage, physical injury or property damage suffered by any person by reason of any defect, accident, negligence or neglect however arising.
- 2. AUTHORITY OF SHOW COMMITTEE:** The Committee reserves the right to cancel, alter or combine any event they may deem necessary. Any unruly animal will be requested to leave the ring or grounds. (Unruly being at the discretion of the Stewards and Judges).
- 3. CONDUCT:** Competitors shall at all times behave in a proper and respectful manner. Judges should not be approached prior, during or after the competition. Any exhibitor whose conduct is considered to be ill-mannered, aggressive or unsportsmanlike may be issued a warning and subsequently dismissed from the class or disqualified from the show. Exhibitors, Competitors and spectators are expected to read and adhere to the [SPPHAWA Show Rules & Policies](#).
- 4. ENTRIES:** Entry fees as set out on the Entry Form will apply. **REFUNDS of entry fees will not be paid unless the event is CANCELLED.** SPPHAWA Inc Committee reserves the right to refuse, cancel or accept conditionally any entry. Exhibitors will not be permitted to compete unless relevant Disclaimer Statement forms are completed correctly and any fees tendered.
- 5. OTT ID PASSPORTS:** Every Standardbred entry MUST PROVIDE a copy of the horses OTT ID PASSPORT or proof of application for the entry to be processed. www.offthetrackwa.com.au/off-the-track-wa-passport/
- 6. HORSE REGISTRATIONS:** All Partbred Standardbreds must be registered with SPPHAWA, please provide copies of papers with entries.
- 7. PRESENTATION:** All Purebred Standardbred's must be presented with plaited or hogged manes, braided or pulled/shaved tails with the exception of Colts/Stallions, Juniors or any Sporthorse discipline that does not require plaiting of horses. Suitable and substantial headgear is required on all horses in the led classes. Partbreds must be plaited or banded. All ridden horses must be fully plaited and ridden in a suitable bridle. Bitless bridles are not accepted. All persons on horseback are required to use a registered standard approved safety helmet. Whips must not exceed 120cm for Led classes & 75cm for Ridden. Please see [Track to Hack Show Guide](#) for all Presentation Guidelines.
- 8. SENSORY HAIRS:** *for Standardbreds only*, all sensory hairs must not be removed (whiskers and inner ears). Ears may be neatened but inner hair must not be removed.
- 9. EXHIBIT NUMBERS:** Competitors may not enter any class without their correct exhibit number clearly displayed either on their back or in a number holder.
- 10. STALLION\COLTS:** may not be handled or ridden by any person under the age of 18 years. Stallions must be under control and always supervised. Stallions/Colts over 2yrs of age must be bitted at all times whilst being handled. **No junior is permitted to ride, handle or be responsible for the care of a Colt\Stallion.**
- 11. ELIGIBILITY OF OTT CLASSICS:** **TO ENTER THE OFF THE TRACK CLASSICS YOU MUST COMPETE IN AT LEAST ONE CLASS IN THE LED or RIDDEN SECTION OF THE DUAL-CODE PROGRAM.**
- 12. STANDARDBRED SPORTHORSE CLASS:** This class is specifically for horses that compete in 'other' disciplines e.g Racing, Jumping, Eventing, Endurance, CDE ect. Proof of performance in the past 45 Days must be provided (results listing from such event) with entry forms. **You cannot enter any other Led Section – Junior, Stallion, Mare or Gelding.** Dressage and Show Horse competitions are not eligible in Sporthorse Criteria. See Page 4 for further clarification.
- 13. STANDARDBRED WALK/TROT ELIGIBILITY:** Any Standardbred that has competed in ANY canter classes is not eligible for the Walk/Trot classes in the Dual-Code program and also the Walk/Trot Classic. This includes competing in Dressage (excludes Prep 3) and jumping over 60cm. **Please read Page 7 of [SPPHAWA Show Rules & Policies](#) for further details on ridden gradings or contact SPPHAWA.**
- 14. LED SHOW HACK\SHOW HUNTER CLASSES:** Horses can only compete in one class, Show Hack **OR** Show Hunter. If you enter both classes you will not be refunded. Descriptions on Hack & Show Hunter can be found in our [Track to Hack Show Guide](#).
- 15. RIDDEN SHOW HACK\SHOW HUNTER\SPORTHORSE CLASSES:** Horses can only compete in one class, Show Hack, Show Hunter **OR** Sporthorse. If you enter more than one of these classes you will not be refunded.
- 16. BEST PERFORMED SPORTHORSE – OTT CLASSIC –** The highest placed "Sporthorse" in each OTT Classic will be deemed the Best Performed Sporthorse.
- 17. SWABBING:** Any exhibit may be randomly selected to be swabbed for prohibited substances throughout the event. Please ensure you have your horses registration cards on hand.



The following pages affect your legal rights and obligations. Please read these carefully and only sign if you fully understand their contents. For Participants under 18 years of age, these documents must be completed by a parent or legal guardian.

Description of Activities¹: Any equestrian event that is run by SPPHAWA

Risk Warning

I am aware that by my participation in any activities arranged by the Provider, certain risks or dangers may occur which could include:

- Physical, bodily or psychological injury or death.
- Physical exertion to which I am not accustomed.
- Failure of equipment or use of inadequate equipment.
- There may be no or inadequate facilities for treatment or transport to treatment if I am injured.
- The conditions in which the activities are conducted may vary without warning.
- I may cause injury to other persons and/or other persons may cause injury to me.
- I may be injured or die due to the negligence, breach of contract or breach of statutory duty or guarantee of the provider.

I acknowledge that the activities are being undertaken for the purposes of recreation, enjoyment or leisure, and involve a significant degree of risk of physical harm. I acknowledge that the Activity may be undertaken with one or more other persons as part of a group and that the Provider is not liable for the actions of other participants in the group activity.

By signing below, I acknowledge, agree and understand that the risks associated with the Activities and/or recreational services have been explained to me. I undertake any such risk voluntarily and at my own risk.

I acknowledge that the risk warning above constitutes a "risk warning" in accordance with the *Civil Liability Act 2002* (NSW) and the *Civil Liability Act 2002* (WA).

Participant's Warranties

I agree to abide by any of the Provider's rules, and any direction or instruction given to me by the Provider during the course of the Activities. I agree to use and/or wear any equipment given to me by the Provider.

I declare that I am medically and physically fit and able to participate in the Activities. I acknowledge that I must, and agree that I will, disclose any pre-existing medical or other condition, injury or concern that may affect the risk that either I or any other person will suffer injury, loss or damage during the course of the Activities and notify the Provider of any injuries, illness or concerns that may arise during the Activity. I will not engage in any reckless, negligent or foolish behaviour or any other behaviour that is likely to cause injury to me, any other participant or person.

I agree that if I suffer any injury or illness, the Provider may provide evacuation, first aid and/or medical treatment at my expense and that my acceptance of these terms and conditions constitutes my consent to such evacuation, first aid and/or medical treatment.

I declare that I have not consumed any alcohol or mind altering substance, or medication that may impact my judgement or physical capacity, before or at the time of engaging in the Activities.

Exclusion of liability

I agree to and unconditionally release, waive, discharge and forever hold harmless, the Provider or any of its employees, agents, directors or officers, from any claims as a result of any personal injury sustained, whether caused by the Provider's negligent act or wilful act or omission, breach of contract, breach of statutory duty, error, or otherwise in connection with or arising out of the Activities.

I agree that the Provider will not be liable for any claims for personal injury that may be brought against it as a result of or in connection with any act, omission, default, failure or error on the part of the Provider, and agree to indemnify and keep indemnified the Provider in respect of any such claims.

Waiver

It is possible for a supplier of recreational services to ask you to agree that the statutory guarantees under the *Australian Consumer Law* (which is schedule 2 to the *Competition and Consumer Act 2010* (Cth)) do not apply to you. If you sign this form, you will be agreeing that your rights (or the rights of a person for whom or on whose behalf you are acquiring the services) to sue the Provider in relation to the Provider's services or the activities that you undertake because the services or activities provided were not in accordance with the guarantees are excluded, restricted or modified as set out below.
